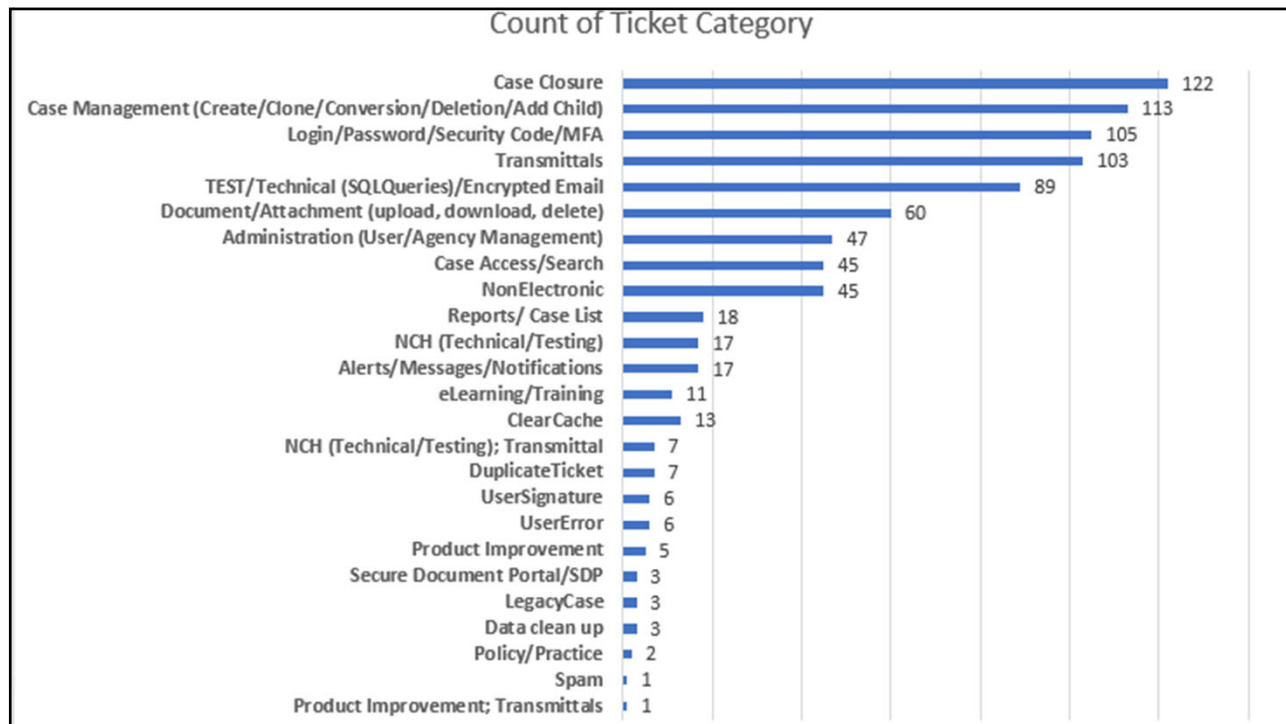

- **Top categories of tickets submitted**
  - Case Closure (N=122, 14.4%)
  - Case Management (creating, cloning, converting, deleting, add child) (N=113, 13.3%)
  - Login Assistance (N=105, 12.4%)
  - Document/Attachment (upload, download, delete) (N=60, 7.1%)

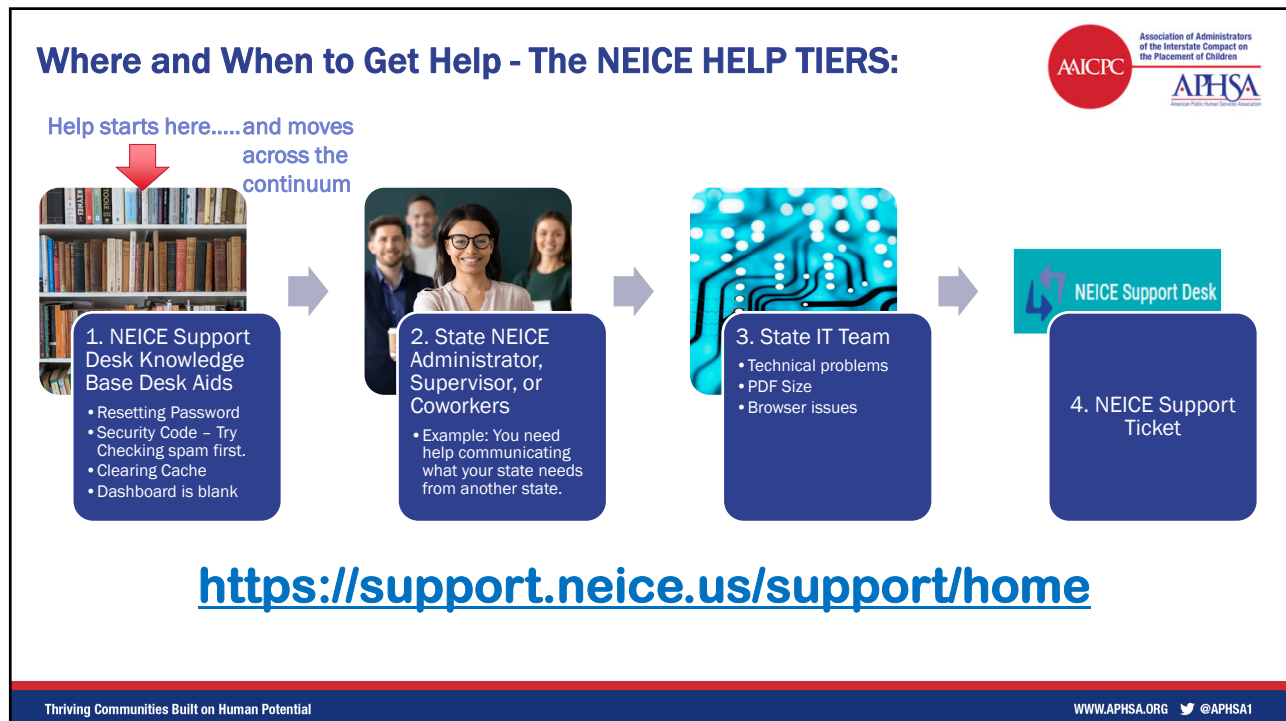





## Job Aids for Reports in NEICE



### 1. Finding Cases Needing Closure

- **Summary:** This report provides a list of active cases that were created prior to the date specified but have had no Transmittals since that date.
- **Who can run report:** ICPC Coordinator & State Administrator
- **Practice Application (Discussion and Showcase):** This report may be used for case management to identify cases where there have not been transmittals sent/received since the date selected, to determine the appropriate action needed on the case.
- **NCH States** – Similar report?

## Job Aids for Reports in NEICE



### 2. Requests Sent to Agencies by ICPC Central Office (Receiving State Only)

- **Summary:** This report provides a list of cases that were sent to an agency or all agencies within the state during the specified date range including the Home Study Decision.
- **Who can run report:** ICPC Coordinator & State Administrator
- **Practice Application (Discussion and Showcase):** Helps to manage and track cases sent to agencies. If "List" is selected the report provides the Safe and Timely Due Date ("SaTA Due Date") with status of the Home Study Decision to help with monitoring timeliness for each agency.

## Job Aids for Reports in NEICE



### 3. Children over the Age of Majority

- **Summary:** This report provides a list of Children who are over the age of majority based on whether the state is Sending or Receiving and the Child's Title IV-E Eligibility.
- **Who can run report:** ICPC Coordinator & State Administrator
- **Practice Application (Discussion and Showcase):** This report may help with caseload management to help identify cases for closure and determine when a child is still eligible for Title IV-E funding.

## Job Aids for Reports in NEICE



### 4. Children Placed In-State and Out of State

- **Summary:** This report provides a list of Children placed either in the state or in another state during the specified date range based on a selected agency or all agencies in that state.
- **Who can run report:** ICPC Coordinator & State Administrator
- **Practice Application (Discussion and Showcase):** May help with caseload management to identify children with regulation types, placement dates and sending state. Could help with monitoring supervision cases.

## Job Aids for Reports in NEICE



### 5. Incomplete Requests - Missing 100As

- **Summary:** This report provides a list of cases created by an agency or all agencies within the Sending State during the specified date range but no 100A has been created.
- **Who can run report:** ICPC Coordinator & State Administrator
- **Practice Application (Discussion and Showcase):** Helps with case management to check and make sure there is not a case created the state has not processed/acted on.

## Job Aids for Reports in NEICE



### 6. 100B Termination Statistics

- **Summary:** This report provides a list of cases that have been terminated during a specified date range based on Date of Termination on the 100B.
- **Who has access to run report:** ICPC Coordinator & State Administrator
- **Practice Application (Discussion and Showcase):** Provides a list of closed cases and includes options to sort the total cases by:
  - 1.Placement type
  - 2.Reason for Termination
  - 3.Reg Type

## Job Aids for Reports in NEICE



### 7. Violation Statistics Report

- **Summary:** This report provides a list of cases where a state is in violation based on a specified date range and the role of either sending or receiving state in a case.
- **Who can run report:** ICPC Coordinator & State Administrator
- **Practice Application (Discussion and Showcase):** May be used to determine the need for additional training, supervision or support.

## Job Aids for Reports in NEICE



### 8. Indian Child Welfare Act (ICWA) Report

- **Summary:** This report provides children and case statistics for an individual Participant State on how many American Indian/Alaskan Native children and cases are in NEICE and how many children and cases have children with ICWA Eligibility for a given date range.
- **Who can run report:** ICPC Coordinator & State Administrator
- **Practice Application (Discussion and Showcase):**

## Job Aids for Reports in NEICE



### 9. State System - NEICE Comparison

- **Summary:** This report provides a list of NEICE Children either not in the State System/SACWIS or with different data in the State System/SACWIS than in NEICE.
- **Who can run report:** ICPC Coordinator
- **Practice Application (Discussion and Showcase):** This Report is used by states with an interface between NEICE CMS/MCMS and state's child welfare information system to compare the data differences.

## Job Aids for Reports in NEICE



### 10. Home Studies Pending/Completed/Overdue

- **Summary:** This report provides a list of Home Studies based on whether they are Pending, Completed, or Overdue. The report returns the current status for cases at the time the report is requested.

The report provides:

- Home Studies Pending – All Home Studies open during the date range specified with the Home Study Decision status = "Pending".
- Home Study Decision Completed – All Home Studies who have a Home Study Decision Sent On Date within the date range specified.
- Home Study Overdue – All Home Studies that have no decision and have passed the due date based on the Regulation Type within the date range specified.
- **Who has access to run report:** ICPC Coordinator & State Administrator
- **Practice Application (Discussion and Showcase):** Helps monitor timeliness of ICPC Home Study timelines.
- **NCH States** – Similar report?
- **Job Aid:** Coming Soon

## Job Aids for Reports in NEICE



### 11. AAICPC Data Report

- **Summary:** This report was requested by the AAICPC to provide eight (8) data points for home studies and placements for a specific year and month for the user's state.
- **Who can run report:** ICPC Coordinator & State Administrator
- **Practice Application (Discussion and Showcase):** Used to submit monthly state data to the AAICPC.
- **NCH States** – Similar report?

### 12. Cases by Title IV-E Eligibility

- **Summary:** This report provides the total cases based on Title IV-E Eligibility to the ICPC Coordinator and the State Administrator.
- **Who can run report:** ICPC Coordinator & State Administrator
- **Practice Application (Discussion and Showcase):** This report is used by states to track Title IV E Eligibility status.
- **NCH States** – Similar report?

### 13. Cases by Type of Care

- **Summary:** This report provides the total (Active and Closed) cases based on Type of Care for Sending and Receiving.
- **Who has access to run report:** ICPC Coordinator & State Administrator
- **Practice Application (Discussion and Showcase):** May help with case management and provides a report on cases by type of care (List or Counts).
- **NCH States** – Similar report?

### 14. NEICE Case Statistics

- **Summary:** This report provides Case, Home Study, and Children Placement counts and the number of Transmittals Sent or Received for the individual Pilot State.
- **Who can run report:** ICPC Coordinator & State Administrator
- **Practice Application:** This report is used by the state to get the overall statistics of the state.
- **NCH States** – Similar report?
