# Outstanding issues and Tips

- Report exports (final beta testing)
- Handling Missouri cases
- Selecting Transmittal Types when sending 100A and 100B
- Closing a Case as a Receiving or Sending State – Mechanism to use is sending 100B Closure– unilateral termination. It's important when a state wants to close a case, you need to notify the other state first.

# How are things *really* working?

  - Challenges closing cases – we've made some changes to make it easier
  - Sending cases created prior to July 7 – Transmission failures, missing information needs to be completed.
