## Introduction

The American Public Human Services Association (APHSA) and the American Association of Administrators of the Interstate Compact for the Placement of Children (AAICPC) is looking to streamline and enhance the business processes around the placement of children across State lines. It is envisioned that this project will enhance the administrative efficiencies and result in efficient processing of Interstate cases from both a timely as well as cost savings perspective. In order to achieve these efficiencies, the AAICPC proposes to utilize technology to support these business processes. While one of the focus areas is the implementation of a technology solution, it is critical that the Pilot implementation demonstrate the following:

- Faster processing of cases,
- Quicker placement decisions,
- Standardization and reporting of interstate data,
- Ability to perform analytic comparisions across multiple components and jurisdictions.

Another potential benefit is the cost savings based on reduction in postage and other costs as well as the time spent by the case workers and users in trying to obtain information about a case. The State of Florida has already developed and is utilizing a system to support its information processing needs. However, there are some system enhancements that will be required to enable this system to be utilized across state lines. In addition, thought and consideration needs to be given to state specific privacy requirements as these cases move across state lines.

One aspect of the development of the NEICE system is the manner in which the State SACWIS / Automated systems will interact with the NEICE system to send and receive data. While the long term vision of the NEICE system is to have the SACWIS / State Systems send the entire ICPC case information to NEICE which will act as an automated clearinghouse, it must be emphasized that this is the final vision. For the purposes of the Pilot, the information exchange between the SACWIS/Automated systems will be limited to the exchange of Child data and Placement resources. This is based on the aggressive timeframes around the Pilot.

This document provides the specifications of the Pilot and the full ICPC Case interfaces so that states can start reviewing this document and move forward from their planning perspective.

## Interface Specifications

This section of the document discusses the specifications for both the Pilot implementation and the final vision once the SACWIS/ Automated systems have been modified to complete the ICPC process within the system.

The NEICE system will support the exchanges in 2 specific formats. These are:

- Web Service Interface
- Secure FTP based interface

Each Pilot state may opt to use one of the formats described below to send the information via the interfaces mentioned above.


- (a) Standards based (National Information Exchange Model) XML exchanges and
- (b) CSV format.

We are providing these options to ensure that we can accommodate the readiness of the Pilot states.

The remainder of this document provides the detailed specifications for the two scenarios (a) Pilot and (b) Future (full ICPC Case)

## Pilot Specifications

In the Pilot phase the NEICE system will support exchange of Child and Placement resources information from the State Systems into the NEICE cloud environment to make it easy for the case workers and the ICPC coordinators to create new ICPC cases and process them. The following gives the transactions that will be supported in the NEICE environment during the Pilot phase.



## CSV Specification

### Child Information Exchange CSV Layout

States can send the updates to any record previously loaded in the NEICE system for performing an update the state must send the entire child record along with the new values for the fields that were modified.


